Interpretation

1. In these Regulations—

"Act" means the Cruising Permit Act;

"charter boat" has the same meaning as in the Act;

"cruising" has the same meaning as in the Act;

"fisheries zone" means the fisheries zone that is contiguous to the territorial sea of Anguilla and that was established by the Proclamation made the 6th day of November, 1981, S.R.O. 28/1981;

"locally-owned boat" means a charter boat-

- (a) totally owned by one or more persons belonging to Anguilla; or
- (b) of which not less than 67% is owned by one or more persons belonging to Anguilla;

"persons belonging to Anguilla" has the same meaning as in the Constitution of Anguilla.

Application for permit

2. (1) Any person may in the form or substantially in the form set out in Schedule 1 apply to the Comptroller of Customs for a cruising permit for any of the periods specified in section 4.

- (2) An application may be made for a cruising permit—
 - (a) at any time before the date of commencement of the cruising permit specifying the date on which it shall commence; or
 - (b) to commence immediately.

(3) Where an application is granted by the Comptroller of Customs, the applicant shall, except as otherwise provided in subsection (4), pay the relevant fees prescribed in Schedule 2.

(4) No fees shall be levied for a cruising permit issued to a locally-owned boat.

Cruising permits

- 3. (1) Every cruising permit shall be issued—
 - (a) in the form set out in Schedule 3; and
 - (b) for a specific boat.
 - (2) No permit shall be transferable.

Validity and duration of permits

4. (1) Every cruising permit shall be valid from 9:00 a.m. on the date on which the permit commences and shall expire at midnight of the date on which the permit expires.

- (2) A cruising permit may be issued for—
 - (a) one day;
 - (b) one calendar week;
 - (c) one calendar month; or
 - (d) three calendar months.

Permits subject to conditions

5. The Comptroller of Customs may issue a cruising permit subject to such conditions and limitations as he may consider fit to impose; and such conditions and limitations shall be valid and enforceable as if imposed by these Regulations.

Agent of the owner

6. Every owner of a charter boat shall—

- (a) have an agent in Anguilla; and
- (b) notify the Comptroller of Customs of the name and address of such agent at any time before making an application for a cruising permit or at the time of making it.

Anchoring prohibited in certain places

7. (1) No charter boat shall anchor in any of the areas set out in Schedule 4 except within the areas of the sea indicated on the maps set out in that Schedule and demarcated by Government of Anguilla marker buoys.

- (2) No charter boat shall—
 - (a) cause loss or damage to coral reefs or the marine environment in the fisheries zone; or
 - (b) dump in the fisheries zone any oil, chemicals or any other substance likely to pollute water or endanger marine life.

(3) Where any charter boat contravenes subsection (1) or (2), any person who was in charge of such boat at the time of the contravention commits an offence against these Regulations.

Supply of false information an offence

8. Any person who makes any declaration or supplies any information required to be made or supplied by the Act or by these Regulations knowing the same to be false in some material particular commits an offence against these Regulations.

Penalty for offences

9. Any person who commits an offence against these Regulations is, without prejudice to any other action which may be instituted against him under the Act, liable on summary conviction to a fine of \$2,000 and, if the offence is a continuing one, to a further fine of \$1,000 for every day or part thereof during which the offence has continued.

Permit confers no rights to enter Anguilla

10. A cruising permit does not confer any right or entitlement on any person to come ashore or enter Anguilla unless he is entitled for the time being to do so under or by operation of any other law.

Cancellation of permits

11. (1) The Comptroller of Customs may cancel a cruising permit—

- (a) where any charter boat violates the provisions of the Act or the provisions of these Regulations or the conditions and limitations imposed by the Comptroller of Customs; or
- (b) where the cruising permit has been obtained by committing an offence under section 8.

(2) The Comptroller of Customs shall, as soon as possible, notify the owner of such charter boat or agent of such owner that the cruising permit has been cancelled.

Citation

12. These Regulations may be cited as the Cruising Permit Regulations, Revised Regulations of Anguilla C165-1.





SANDY ISLAND






PRICKLY PEAR CAYS & SEAL ISLAND REEFS
