DISTRIBUTION AND PRICE OF GOODS ACT, R.S.A. c. D30

DISTRIBUTION AND PRICE OF GOODS (MAXIMUM PRICE ORDER) REGULATIONS, 2020

Regulations made by the Minister under section 2 of the Distribution and Price of Goods Act, R.S.A. c. D30.

Interpretation

1. In these Regulations—

“C.I.F.” means cost, insurance and freight used in determining the normal price of goods under the Customs Act.

Order by Minister

2. (1) The Order providing for the ascertainment of the maximum price of specified goods is set out in the Schedule.

(2) The Minister may, by notice published in the *Gazette*, revise the list of price-controlled goods as provided for in Part B of the Order.

Notice of extension of time

3. At any time before the expiry of these Regulations, the Minister may, by notice published in the *Gazette*, extend the time for which these Regulations are scheduled to expire.

Commencement and expiration

4. These Regulations come into force on 9 April 2020 and expire on 9 July 2020.

Citation

5. These Regulations may be cited as the Distribution and Price of Goods (Maximum Price Order), Regulations, 2020.

MAXIMUM PRICE ORDER

PART A

I **Victor F. Banks, Premier and Minister responsible for Trade and Industry**, in keeping with the power vested in me in accordance with section 2 of the Distribution and Price of Goods Act make the following Order—

- (a) where goods listed in Part B are sold by retail the maximum price shall be as follows—

C.I.F. plus 40% mark-up; and

- (b) where goods listed in Part B are sold by wholesale the maximum price shall be as follows—

C.I.F plus 20% mark-up.
